### PRODUCT DESCRIPTION

A power supply that will provide either 5 Amp 12V DC(13.7) or 2 Amp 24V DC(27.4). The output voltage is changed by means of a simple selector plug. The unit provides two separate outputs and will house and charge two 12V 7Ah VRLA batteries. Typical uses are for powering door access controllers, electric releases and maglocks. The unit has separate SPCO (Single Pole Change Over) contacts for 'Mains Fail' monitoring. Metal cased.

The unit also has an undedicated SPCO relay that can be driven from a 12V or 24V DC supply. A typical use for this relay would be interfacing a fire panel with the power supply to de-power maglocks in the event of a fire condition.
